2014 Text4baby State Enrollment Contest Large State Winner: New York

According to the March of Dimes' Peristats, there are approximately 240,916 live births in New York annually. Unfortunately, 10.7% of these births are pre-term, 7.9% are born at low birth weight, and 5.1 babies per 1,000 died before their first birthdays. These statistics highlight the need for innovative strategies at the national and state level to address maternal and child health.

2014 Text4baby State Enrollment Contest

In honor of Mother's Day, Text4baby launched the 4th Annual State Enrollment Contest. The State Enrollment Contest is a national competition that aims to empower more pregnant women and new moms with important health and safety information through Text4baby by encouraging friendly competition between the states. The Contest ran from May 11 through November 1, 2014.

States competed in the contest in three distinct groups based on the overall distribution of 2012 live births with the goal of having states with similar numbers of estimated NEW pregnancies and NEW infants competing against each other. The large state category includes all states with live births in the upper quartile (highest 25%). The medium state category includes all states with live births in the middle 50%. The small state category includes all states with live births in the lower quartile (lowest 25%).

This approach balanced the distribution of live births and provided states with the fairest possible opportunity to win given the wide variation in live birth rates across the country. The states were ranked based on how many new users enrolled in Text4baby in each state during the contest period as a percentage of eligible moms (based on a calculation of estimated pregnancies and live births for each state).

Enrollment in Text4baby


New York came in first place for the large state group, enrolling 30 per 1,000 estimated new pregnant women and moms into the service. During the contest period, a total of 7,004 new users enrolled in the Text4baby service in New York. New York's enrollment was 16% higher during the contest compared to the 25 week period prior to the contest.

Promotional Activities during the Contest Period

More than 50 partners in New York joined together to promote Text4baby through a variety of creative efforts including a state wide marketing campaign and targeted outreach through health plans and community activities.

The New York State Department of Health launched a broad-reaching marketing campaign for three months during the Contest, which included subway and bus advertisements, targeted Facebook ads and other web promotion. These ads were very visible in high traffic areas of New York, going a long way to boost awareness and enrollment. The State Department also customized Text4baby for New York participants, providing the added benefit of offering local resources in their text messages.

Additionally, health plans, including HealthFirst in New York, promoted Text4baby to their members. HealthFirst promoted Text4baby through their online resources for members and has a dedicated page to educate women about the service and how to enroll. Hospitals, community clinics, WIC programs and healthy start projects around the state also increased promotion of Text4baby, helping to bring more women to the service as they were offered other health resources. Congratulations to New York partners on this significant effort to connect more mothers to Text4baby!
