

# Connecting Moms to Health Insurance and Health Information:

## Ways to Integrate Medicaid/CHIP and Text4baby Enrollment

### Text4baby Helps Connect Moms and Babies to Health Insurance

Connecting Kids to Coverage -the outreach and enrollment initiative of the Center for Medicaid and CHIP Services - and text4baby have joined forces to make it easier for moms to take charge of their family's health.

For pregnant women and new moms who sign up, text4baby delivers three text messages a week with critical health and safety tips, including information on enrolling in Medicaid and CHIP. The messages are timed to their due date or baby's birth day. Text4baby is a free educational service of the National Healthy Mothers, Healthy Babies Coalition. There is no cost to sign up; even if a mom does not have a text messaging plan, she can receive these messages for free. ### **Get Involved**

You can join us in coordinating text4baby with Medicaid/CHIP enrollment using these easy steps:

- Incorporate information about Medicaid/CHIP & text4baby in printed outreach and enrollment materials.
  - Text4baby: Get free, health tips and support on your cell phone with text4baby. Text "BABY" (or "BEBE" for Spanish) to 511411. For more information about text4baby, please visit www.text4baby.org.
  - Medicaid/CHIP: Need health insurance for you or your baby? Learn more about Health Coverage in your State by Calling: 1-877-Kids-Now or by visiting www.insurekidsnow.gov.
- 2. Distribute free co-branded tearpads (40 sheets each) that have Medicaid/CHIP contact information and details on the text4baby service for you to share with clients.
- 3. Place Insure Kids Now (http://insurekidsnow.gov/spreadtheword.html) and text4baby sign-up buttons (http://www.text4baby.org/index.php/text4baby-enrollment-button-info) on your website.
- 4. Collaborate with agencies that have direct contact with new moms.
  - Florida Covering Kids & Families has partnered with the Florida Department of Health's Office of Vital Statistics to include information about free or low-cost child health insurance and text4baby on the envelopes used to mail birth certificates.
- 5. Include links to text4baby enrollment page (http://www.text4baby.org/index.php/sign-up) and Insure Kids Now (http://www.insurekidsnow.gov/) in online Medicaid/CHIP enrollment forms.
  - Oklahoma Health Care Authority has initiated the process for adding a text4baby link to the online SoonerCare application and the electronic newborn enrollment form used in hospitals to enroll infants in Medicaid just after birth.
- Insert an automatic text4baby enrollment feature on Medicaid and CHIP online enrollment forms.
  - Partners in San Diego have adding text4baby enrollment to their web-based Medicaid/CHIP enrollment service, One-e-App, giving individuals the opportunity to apply for various health social and support services in one web-based application.
- 7. Incorporate text4baby enrollment into other online and printed forms like pregnancy risk assessment forms completed by providers.
  - Web-based prenatal behavioral health screenings, like the Louisiana Health Assessment Referral and Treatment (LaHART) tool, can be set up to include text4baby enrollment in the streamlined screening and referral process for pregnant Medicaid-eligible women in need of treatment for substance/alcohol abuse during pregnancy. Providers are paid for conducting the screening.

- 8. Feature Medicaid/CHIP & text4baby in newsletters, broadcast emails, and other communications.

- 9. Plan and host an enrollment drive in your community with the support of partners, elected officials, local businesses, families, advocates, and local media.
  - Have volunteers and trained staff (i.e. CHIPRA grantees, FQHC staff, certified application assistors if available) on hand to assist attendees in navigating the state-specific Medicaid/CHIP enrollment forms. They can help moms sign up directly through their cell phones for text4baby the best way to get moms connected to the service!

- 10. Discuss text4baby and Medicaid/CHIP services within the programs/services offered at your facility.

### Sample Text4baby Messages:

By signing up moms for text4baby, you're also helping connect them to Medicaid and CHIP. There are dozens of messages that provide the user with information on obtaining free/low-cost health insurance, accessing services covered by Medicaid/CHIP, and renewing Medicaid/CHIP coverage. Additionally, a special Medicaid/CHIP text4baby module is coming soon, reinforcing these messages and providing more information on applying for Medicaid/CHIP. This module will send reminders about applying and reapplying for Medicaid/CHIP. The module will be timed to send reminders to ensure that the user is on schedule to apply for Medicaid/CHIP and reapply before their coverage runs out. Text4baby messages are developed with the support of the American College of Obstetricians and Gynecologists, American Academy of Pediatrics, Centers for Disease Control and Prevention, and dozens of other health and safety experts. There are no advertisements or product promotions.

### Messages include:

- Medicaid pays for pregnancy check-ups & delivery. If income is less than \$35,300 (family of 3), U may qualify.
   Get kids insurance too: 877-543-7669.
- If you need to take your child to the dentist, Medicaid/CHIP covers dental care for kids who qualify. Call 877-543-7669 or go to www.insurekidsnow.gov.
- Your child may qualify for free or low-cost check-ups, shots, sick visits & more with Medicaid/CHIP. Call 877-543-7669 or go to www.insurekidsnow.gov.
- If you have Medicaid/CHIP, don't forget to renew before coverage runs out. Look for a renewal notice in the mail. Have questions? Call 877-543-7669.
